Report from Chief and Command -

Call Summary - April 93 calls, down 3 calls from last year.

Attorney's report -

Attorney Flaherty welcomed the new Trustees.

Pension overturned by the Illinois Supreme Court. Skipped the Appellate Court, went straight to Supreme.

Legislative Report – Two Bills pending; House Bill 695 and House Bill 699. Both these bills will do negative for taxing bodies. It will put every taxing body in the state on a tax cap. Stating in 2015 levy there will be no CPI, it is 0%. The only way around it would be to go to referendum. It does not address TIFs, merged districts or new growth. Why two bills? One bill applies to home rule municipalities the other does not. 699 exempts home rule, 695 does not. Amendments have passed, but the Bills have not.

Naden hearing starts tomorrow – first day of testimony.

Old Business -

Discussion was held on the TIF #2 that was passed by the Sugar Grove Village Board. The District tried to negotiate with the Village and have an IGA signed by both boards, the Village Board declined the proposal.

Items 10b Establishment of a Fee Ordinance and 10c Post-retirement Healthcare Funding Plan are tabled.

It was motioned by Linden and seconded by Fagel to:

'Go in to closed session at 7:43pm for discussion of Possible/Probable Litigation.'
