Chief Perkins stated that the college just sent a report that they are reviewing this. Fagel stated he would like to be directly involved in this. Chief stated the campus police are the ones that are doing this, and he should reach out to them.

Report from Chief and Command – 97 calls for the month of September – down by 80 calls for the year. Estimated EAVs – expects about additional \$100,000 over last year. Will have copies in Trustees packet next month.

Attorney's report – Pension board subpoena served. Attorney will take care of it – any questions will be answered in closed session.

Old Business - Dugan Woods's mailbox settlement paid - \$150.00.

New Business – Annual Receipts and Disbursements – this is an annual document that needs to be approved by the Board, published in a local paper and then filed with the county.
