Correspondence -

Trustee Davis stated that Bill Wyatt is looking for ways to cover a \$300,000 deficit for the Aurora Airport.

Treasurers Report -

Operations Account – \$3,069,204.48, Construction Account - \$558,016.40, Total \$3,627,220.88 At about 53%.

It was motioned by Guddendorf and seconded by Davis to:

Report from Chief and Command -

Calls at 96 this month – down from last year. Overall at 80 calls down from last year.

Grant moving forward for POC program. POCs can get \$75 a month towards certain things, also a 3-year \$50,000 accidental death/dismemberment policy. New POCs, after August 2016, can get continuing education.

Attorney's report -

Attorney Flaherty stated he filed a motion to dismiss everyone except the pension fund, will get decision by 2nd week in December.

Attorney Hoppa stated the TIF expert is a little behind, he will have more info at next meeting.

New Business -

Levy Ordinance – This is a yearly ordinance to be approved by the Board of Trustees and filed with the county.
