Treasurers Report -

Operations Account – \$2,898,302.97, Construction Account - \$558,018.04, Total \$3,456,321.01 At 56.8% - Right on target, as some high dollars items have been paid out already.

Expenditures -

Chase Checking - \$226,292.93, Chase HRA - \$2,384.46, Total expenditures \$228,677.39

Report from Chief and Command -

Call Summary – 89 calls this month – Down 1 call from last year – overall down 80 calls for the year. Consistent with other districts in the area.

Ordinance to adopt new fire prevention codes – this is for Trustee's to review and will be on agenda next month.

Would like to get the Development Fees account set up for bill pay. Paula will get information and paperwork that needs to get this done, and it will be on agenda next month.

Chief brought up issues with the Mutual and Automatic Aid Responses. It was determined to have Chief try to resolve the issues.

Attorney's report -

Naden Case – Trustees have been dismissed. Pension Board member are still expected. Closed session tapes, subpoenaed by Naden's attorneys, denied by Judge, will not be release. Trial will take place second week in April 2016.

911 Funding - Springfield released the funding.

Linden questioned the TIF – Hoppa stated he hopes to have something for the January meeting.
