Treasurers Report -

Operations Account – \$2,566,475.77, Capital Account - \$1,252,873.68, Total \$3,819,349.45 Next month percentages will be attached.

'Accept the June 2017 Cash Balances and Budget vs Actual Reports'

Roll call vote - Motion carried

Expenditures -

Chase Checking - \$429,672.68, Chase HRA - \$12,163.90, Total expenditures \$441,836.58 Chief Perkins stated the reason the expenditures were high for this month is because a Kane County tax payment was received and we made payment to the pension account.

Village has new vendor for trash pickup – they did not negotiate for free pick up for the fire district, with Waste Management the district had free pickup service. Chief will call the new vendor to see what they will do.

Report from Chief and Command -

June - 100 calls - most calls in June since 2013

Chief stated he would like to sell the boat and try to get a smaller one, the one we have is too large for any body of water in our district. Trustees would like him to get numbers on what a new boat would cost.

Corn Boil starts this Thursday.

Bond Payment – received a call from Bank of NYM stating the principal amount for the bond is not due in July, but January. They would like to send us the money they are holding. Chief to call Baird to find out what the issue is.

Trustees Report – Trustee Fagel stated that he talked with Brent Eichelberger concerning the annexation of the property near the 47/I88 area. Fagel stated that he would like two SGFPD trustees to meet with two Elburn trustees to discuss a solution to the borders of that area.

Attorney's report -

State budget passed – no property tax relief, no tax freeze.

Illinois Appellate Court heard arguments in the Lt case - no opinion was made, possibly by August.
