Treasurers Report -

Operations Account - \$1,572,948.97, Capital Account - \$1,074,743.09, Total \$2,647,692.06

Final totals were at - 93%

Discussion on the net ordinary income – this area is for accountant only. Paula will send email with explanation from accountant to the trustees.

Expenditures -

Chase Checking - \$207,353.11, Chase HRA - \$8,624.94, Total expenditures \$215,978.05

Report from Chief and Command -

94 calls for this month – down by 5 from last year.

Monthly report was discussed.

Training report from BC Lopez was given to Trustees – this highlights all of the training that has been done in 2018 to date.

Attorney's report -

Lt.'s case - Still waiting on IL Supreme Court

House Bill 4242 – Passed unanimously – waiting on Senate. This bill covers severance/leave (sexual harassment) every time a payment is made – needs to be reported and published in newspaper.

Old Business -

- 11a) Airport response and fees [Chief Perkins] still waiting on return call
- 11b) TIF/Impact Fees Trustee Guddendorf attended village meeting [Guddendorf] village wants to combine TIFs as one this could make for the ability to start the clock over for the 23 years. Easy way to transfer money from one TIF to the other if they are connected. Guddendorf will continue to attend village meetings.
- 11c) Boundary Discussions [Fagel] move forward or drop the issue. After long discussion it was decided there needs to be a follow-up with Eichelberger on status of Airpark.
- 11d) Coop-plan still developing.
- 11e+f) Capital Plan/Strategic Plan Chiefs Capital Plan was finished in December, waiting on trustees approval. Guddendorf handed out his Strategic Plan, which incorporates the Capital Plan into it. [Guddendorf] Capital Plan is done, unless someone does not like what is in it for the first 10 years. [Guddendorf] Strategic plan goes out 30 years, includes adding new building, manpower, and vehicle updates within the next 30 years, and the amount of money needed to continue. Discussion was held on the objectives of this draft plan.
