### Trustees Report - Nothing to report

### Report from Chief and Command-

Monthly report is in packet to Trustees. Calls increased by 72 over the past year.

Discussion was held on TIF2. Chief Perkins will attend the village board meeting on Tuesday and reiterate the concerns it has on the fire district.

## Attorney's report -

Pension legislation went into law – will get a 30-day notice about transferring funds.

Will need to put changing stations in both public restrooms. – These will be ordered and put in both bathrooms on the public side of the building.

Waiting on dates for Naden case.

#### Old Business -

Drug and Alcohol Policy Change – any changes for Local will have to be negotiated in the CBA. Changes made to policy is for administration and non-union personnel.

Fire Alarm Control Panel -

AC Parson received two quotes from two vendors to replace the control panel – the quotes were \$10 apart. After much discussion it was decided to stay with the same company we have been dealing with.

'Approve the replacement of the control panel and annunciator from ADS not to exceed \$3500.00'
