Chief stated it depends on availability but will look into it. Trustee Cicero stated he is registered for the Trustee conference in October.

Report from Chief and Command -

Monthly report in packet. August 109 calls - up 12 from last year - down 50 for yearly total.

Chief Perkins stated that he would like to replace the cabinets, countertop, and flooring in the small break room. There is mold in the back of some of the cabinets, and some of the tiles have had water damage.

Trustee Cicero asked about Kit and his shoulder. Chief Perkins stated it is non-work related and he will be out for about 5 months on sick leave.

Chief Perkins stated the interviews were conducted, he has 10 days for the Final list to be posted, and then he will move through the candidate list.

Attorney's Report – there will be six days of Legislative Session after the election.

Pension Board met and voted for Line of Duty Disability – she will also receive a check from the date she last worked. Board served with litigation – will discuss in closed session.

Nixel 360 - Chief Perkins had conversation with Chief Rollins, feels this will help us be more proactive with the residents – residents will have the option to opt in – this will keep the residents informed of any emergency situations. First year cost \$3650 - this includes the initial set up. 3-year guarantee at \$3400. Chief Perkins would like to only do one year, to see if it is worth the cost. Discussion was held on the cost and benefits of the program.
