Chief should be receiving remaining funds for Kane County Corona Relief Fund this week. Covid vaccine declination form was passed out. Battalions are being trained on Nixle system. Chief is working on Nixle notification options for public.

Attorney's report -

[Flaherty] Madigan leaving as Speaker of Illinois House. Two Bills passed both affecting fire departments and both related to Covid. Dates are extended from December 31, 2020, to June 30, 2021 for Workers Compensation Presumption and the extension of PEDA 12-14 months. For Federal laws Biden has announced he has a Covid Bill for \$1.3 trillion. The Fire Departments would be offered additional reimbursement money and to reinstate and fund the Paid to Leave provision. If that passes, he will advise.
