## Report of the Fire Chief - Acting Chief Wayne Parson

Up 31 calls for this month – if we continue this pace, we will reach over 1600 for the year.

The family of Charles Steininger had donations sent to the fire district in lieu of flowers – we have received \$795.00. In the past this money would have been given to the Auxiliary for use at Christmas for a family in need. Would like to keep that tradition going. This money will be deposited and earmarked for this - it will be placed in the budget for next year. Thank you(s) will be sent out.

JR Herra – Tankless water heaters - \$600 for service and maintenance – to keep under warranty – do maintenance this year, see if it is worth it for next year.

### Attorney's report -

Agreement with Chief Perkins was delivered, not rescinded, so it is intact.

Legislation that has passed through the one house:

HB5171 - Permanently places a Fire District representative on the pension investment board

HB4924 - Allows Fire Districts to cease paying for a bond for the treasurer of the pension fund

SB3027 - Allow for \$500 state tax credit for volunteer ff's who earn \$10,000 a year or less

SB1571 –Foreign Fire Insurance funds would no longer go through the district –would allow the FFI Board to directly collect the funds instead of going through the Illinois Municipal League.
