#### Trustee Fagel moved up 12A, presentation from Sikich, on the agenda ...

Brian LaFever and Debbie Crabtree from Sikich presented the Financial Model, Reserve Fund Summary.

- 1.7 million was moved into the Capital Fund for this FY
- 3-months reserve in policy- inflation taken into account- falling below that at FY26
- Needs to be updated yearly because of economic cycle
- Look at it every 3-4 month
- Changes can be made at any time give changes to Sikich
- FY 23 budget is baseline in 6-months if you spend more than 50% on your recurring budget items, those need to be updated and looked at closely
- This is a draft it is conservative

#### Trustees Report -

Trustee Fagel

- Questioned Firehouse/ESO will our data still be accessible yes, we have access to it.
- Sterling Rock Falls firefighter death
  - o Handed out pamphlet and list of items lacking

#### Report of the Fire Chief -

- Recreating the call sheet for the packet
- 122 calls in March 385 for the 3 months this year.
- Significant calls
  - o Somonauk change of quarters for their structure fire
  - o Div XIII Hazmat Team oil leak in Aurora
- Updated 30-60-90 in Trustees report
- All three shifts got their 30-60-90'- should have them back in May
- Things seem positive and people working well together

## Attorney's report -

- General Assembly finished early campaigning
- Getting rid of bond for pension treasurer passed unanimously
- Foreign Fire Insurance bill passed is more at the municipality level, not fire districts
- State budget 1% grocery tax is suspended \$300 property tax for primary house is taken off 2021 taxes these will not affect the fire district
- State cut 5m from 911
- May 1 deadline for filling out Economic Interest Statement

  - o One has broken rungs
  - o Operational has been tested over the years has not been in use
- Extrication Tools

- o AMKUS Manual power unit, gas power unit, spreaders, cutters
- o AMKUS (2) combination tools, rams, supply hoses
- Hose
  - o All is either damaged, rotting or in state of non-repair
- Vehicle Command Boxes
- Items donated to Equality the old cascade, the operation ladder, the AMKS tools. And the command boxes if they want them.
- Ladder with broken rung with be destroyed of
- Hose can be given to someone who uses it for other than its purpose or it will be destroyed

## Mutual Aid Agreements -

- Discussion has been held with 3 area Fire Chiefs on auto/mutual aid agreements
- Nothing in writing yet still working on
- Moran would like authority as Chief to sign off on them Board has no problem with that
- NextGen911 Boundaries are handled by different dispatch centers
  - o Area Chief's agreed to send someone, and they will figure out when they get there

#### Filling Firefighter/Paramedic Vacancy - Will talk about after closed

## **Entry Level Testing –**

- Two vendors have been contacted by BC Lopez
  - o Testing for Public Safety LLC
  - o IOS
- Commissioners have been contacted
  - o They want to be involved in the selection process
  - o They would like to have appropriate training
- Current list could be exhausted very quickly
- Need Board approval to interview and hire testing company
- Both companies are comparable in pricing and will do training for commissioners

## Appointment to Pension Board -

- Pension Board is made up of two appointees from the District Board
  - o Chief Perkins and Harry Davis
- Board is having changes Ali VanHorn and Josh Lopez are on as active members
- Kellie Blankenship resigned as the retired member
- By statute the Treasurer is supposed to be on the Board
- When are terms up for Perkins and Davis

- Harry Davis will continue to serve on Pension Board
- Treasurer is responsible for signing all the warrants
  - o she does not have to be on the board
  - o but she is tied to the board

Trustee Fagel questioned if equipment has been returned. Not at this time, he knows he has it and will return it

## Engagement Letter from Lauterbach & Amen -

- This is a one-year contract
- We will have a new person in the company that will oversee the audit
- Cost is \$\$8,675
- Would like to sign the 1-year now it is late in the year
- Will look next year to see what other companies are out there and their costs and services
