Bidding/Purchase Concrete Floor Coating

- Current coating is flaking off
- Diamond grind to original flooring
- Will be done in 2 sections about 1 week for each section
- Will use HEPA filters

Hiring Energy Broker -

- Contract is up in July with current broker
- Have reached out to them, another broker can get us better rates
- One contract locks us in with NICOR at .6969 a therm
- We can save about \$3500 if we use what we used last year
- Current broker does not work with NICOR
- ComEd contract is flexible can get out of it with ComeEd Nicor buys 3 years

Trustee Guddendorf will reach out to Trustee Blankenship. If he does not come back they can take corporate action to eject him – he has three years left on his term.
