# Truth in Taxation and Levy -

- Kane County provides a good estimate of what the EAV will be for the upcoming year
- The overall EAV that is being used is 571,762,743
- New Construction is 2,067,121 which is 0.36% which is \$14,141 of new construction
- This is the first year since the tax cap law in 1991 that we are going to use 5% in Lieu of CPI
- Tax Cap Law says we use the lower of 5% or CPI- 5% is the lower this year because of inflation
- Have to have Truth in Taxation Hearing Notice will be put in paper Public can come to meeting and speak
- Attorney Flaherty's office will take care of the publication
