Trustee Fagel attended the NIAFPD seminar in Lisle on October 22, 2022 – Trustee Fagel gave a handout on key points of the seminar.

Report of the Fire Chief -

- Chiefs report given to Trustees
- 127 calls for month of September 2022
- Total of 1111 from 01/01/-09/30
- Bay floors complete received a \$1000 discount for bleed through of yellow striping
- New Engine is finished punch list items going on
- Alternator going in Pierce engine got it from manufacturer for \$2600 Pierce wanted \$4600
- Gutter repair finished
- Back yard drainage got permit from Village
- Home Depot Grant \$17,300 will cover:
 - o Paint bunk rooms
 - o Bay walls getting painted
 - o Replace patio door
 - o Landscaping project out front
 - o Countertop for breakroom kitchen
 - o Laminate flooring will be replaced throughout station
 - o All labor is free

• Swot meeting – 15 of 25 members attended – BC Lopez wrote up narrative from all the bullet points – next meeting will be in November

Question on the lowest bid that came in -

- does it need to be rebid if it is not completed this year
- Attorney stated no it was already awarded

Attorney's report -

- Election is November 8
- Summit took place it is 13 fire service-related groups in state that goes over pieces of legislation
- 4 Bills passed as consensus Bills
 - o One is to increase bids from \$20,000 to \$30,000
 - o Pension Fund some districts have not been able to add one
 - o Sell real property with a regular appraisal instead of an MAI appraisal
 - O Clarify existing law so we can hold reserve funds and other funds besides the Corporate funds

Old Business -

Truth in Taxation -

- Levy in the amount of \$3,928,639
- Increase of 7% over last year
- Expect to receive at least a 6% increase
- The Pension figure of \$300,582 comes from the actuary as well as the \$22,943 which is exempt from PTELL
- File with the County

Ambulance Billing Rates -

- The GEMT Report filed for this year identifies that the ambulance billing rate should be \$2504.
