- Issued an unmodified opinion - a clean opinion and the highest opinion they can issue
- Financial statements are materially correct
- MD&A narrative summary - highlights changes for this year - All financial information on those 4 pages
- Overall decrease in fund balance of \$60,000 - ending fund balance approx. 4.7m - 1.6m unrestricted
- General fund - both funds coming in underbudget for expenditures
- Management letter - new GASB Standards will all be implemented as required - could have financial impact in coming years


