- HB2216- Fire protedion distrids may charge, and coiled reasonable fees from independent living facilities, assisted living facilities, nursing home facilities, for lift-assists
- SB3206 Lithium-ion batteries are included as hazardous materials
- SB2879- Changes the requirement for competitive bidding for fire protection district contracts to contracts over \$30,000 (currently, over \$20,000)
- SB3163/HB4354 The board of trustees of a fire protection district may accumulate funds for the purposes of emergency medical services, technical rescue, and other services performed by the fire district and for the purposes of providing employees other postemployment benefits
- Attorney will be at meetings unless Chief states they are not needed.
